Report on the Financial Statements

We have audited the basic financial statements of Martin County, Florida (the County) as of and for the fiscal year ended September 30, 2018, and have issued our report thereon dated March 28, 2019.

Auditor's Responsibility

We conducted our audit in accordance with auditing standards generally accepted in the United States of America; the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States; the audit requirements of Title 2 U.S. *Code of Federal Regulations*, Part 200, *Uniform Administrative Requirements, Cost Principles, and the Audit Requirements for Federal Awards* (Uniform Guidance); and Chapter 10.550, *Rules of the Auditor General*.

Other Reporting Requirements

We have issued our Independent Auditor's Report on Internal Control over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements Performed in Accordance with *Government Auditing Standards*, Independent Auditor's Report on Compliance for Each Major Federal Program and State Project and on Internal Control over Compliance and Chapter 10.550, *Rules of the Auditor General*, Schedule of Findings and Questioned Costs, and Independent Accountant's Report on an examination conducted in accordance with AICPA *Professional Standards*, AT-C Section 315, regarding compliance requirements in accordance with Chapter 10.550, *Rules of the Auditor General*. Disclosures in those reports and schedule should be considered in conjunction with this management letter.

Financial Condition and Management

Sections 10.554(1)(i)5.a. and 10.556(7), *Rules of the Auditor General*, require us to apply appropriate procedures and communicate the results of our determination as to whether or not the County has met one or more of the conditions described in Section 218.503(1), Florida Statutes, and identification of the specific condition(s) met. In connection with our audit, we determined that the County did not meet any of the conditions described in Section 218.503(1), Florida Statutes.

Pursuant to Sections 10.554(1)(i)5.b. and 10.556(8), *Rules of the Auditor General*, we applied financial condition assessment procedures. It is management's responsibility to monitor the County's financial condition, and our financial condition assessment was based, in part, on representations made by management and the review of financial information provided by same.

MLC 2018-001 – Journal Entries

Condition:

During our testing of journal entries, we noted that the County currently follows a manual process for posting journal entries which requires a second individual to review and sign off on a hard copy printout of the journal entry prior to posting the journal entry. However, in the County's financial software, Banner, certain users have the ability to circumvent this manual procedure because they have user rights which allow them to both enter and post journal entries within the software.

Criteria:

Proper segregation of duties over journal entries should prevent the same individual from being able to both enter and approve journal entries in the financial software.

Cause:

It appears the Banner software has an approval workflow option for journal entries, but the County has not yet implemented this feature.

Effect:

The manual process can be overridden within the County's accounting software due to the current set up of certain users within the software. This issue could result in unauthorized journal entries, which could potentially lead to errors in the County's financial reporting.

Recommendation:

We recommend that the County implement the approval features within its Banner software to improve its IT controls over journal entries.

Management Response:

Although there are multiple approval and verification layers in place for journal entry processing, the County agrees that utilizing a two person journal entry input process would enhance existing checks and balances. Steps have already been taken to coordinate with the County's information technology department to enable the Banner software features that would require two separate users to complete journal entry input into the general ledger.
